

## **Hampton University Cares Act Student Aid Quarterly (HEERF-I)**

### **ACKNOWLEDGEMENT OF FUNDING AND CERTIFICATION**

Hampton University signed the CARES Act Certification and Agreement on April 24, 2020, and received its grant award notification on April 25, 2020. The University intends to use no less than 50% of the total funds received under Section 18004(a) (1) of the CARES Act to provide Emergency Financial Aid Grants to students.

### **FUNDS AWARDED**

The University received \$2,132,171 from the Department of Education pursuant to the University's Certification and Agreement for Emergency Financial Aid Grants to Students.

### **FUNDS DISTRIBUTED TO STUDENTS**

A total of \$2,132,171 in emergency grant funding through the CARES Act (student portion) was distributed to students as of December 31, 2022.

### **STUDENT ELIGIBILITY**

During our preliminary assessment of student eligibility, we determined that 3,315 students met the Title IV eligibility criteria set by the Department of education, and 1,093 met Federal Pell Grant eligibility.

### **NUMBER OF STUDENTS RECEIVING FUNDS TO DATE**

Emergency grant funding through the CARES Act was distributed to a total of 3,182 students as of December 31, 2022.

### **METHODOLOGY USED TO DETERMINE GRANTS TO STUDENTS**

Hampton uses the following methodology to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a) (1) of the Cares Act:

- Each 2019-20 Title IV-eligible undergraduate, graduate and graduate professional/continuing education (CE) student enrolled in the spring 2020 semester, including 2020 graduating seniors, will receive \$500.

- Each 2019-20 Pell-eligible returning undergraduate and continuing education (CE) student enrolled in the spring 2020 semester will receive an additional \$405, for a total of \$905.

Hampton uses the following criteria to determine student eligibility for CARES Act Emergency Financial Aid Grants:

- Filed a 2019-20 FAFSA prior to the 2019-20 academic year;
- Enrolled at Hampton during the spring 2020 semester;
- Determined by the Financial Aid Office to be eligible for Title IV aid; and
- Determined by the Financial Aid office to be eligible for Federal Pell Grant.

#### INSTRUCTIONS OR DIRECTIONS PROVIDED TO STUDENTS

Hampton informed all eligible students of the process for applying for Cares Act Emergency Financial Aid Grants via email. Hampton also posted information regarding CARES Act Emergency Financial Aid Grants eligibility on the website.

### **FUNDS AWARDED**

The University received \$2,132,171 from the Department of Education pursuant to the University's Certification and Agreement for Emergency Financial Aid Grants to Students.

### **FUNDS DISTRIBUTED TO STUDENTS**

A total of \$2,132,171 in emergency grant funding through the CARES Act (student portion) was distributed to students as of December 31, 2022.

### **STUDENT ELIGIBILITY**

During our preliminary assessment of student eligibility, we determined that 3,515 met the Title IV eligibility criteria set by the Department of education, and 945 met Federal Pell Grant eligibility.

### **NUMBER OF STUDENTS RECEIVING FUNDS TO DATE**

Emergency grant funding through the CARES Act was distributed to a total of 3,269 students as of December 31, 2022.

### **METHODOLOGY USED TO DETERMINE GRANTS TO STUDENTS**

Hampton uses the following methodology to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a) (1) of the Cares Act:

- Must have been enrolled during Spring 2021 academic semester
- Must have been enrolled during the Spring 2021 academic semester as of March 12, 2021 in at least 6 credit in a degree-seeking program or in a Teacher Certification program
- Submitted FAFSA for 2020-21 aid year
- Must have made satisfactory academic progress toward the completion of a degree certificate

Hampton uses the following criteria to determine student eligibility for CARES Act Emergency Financial Aid Grants:

- Filed a 2020-21 FAFSA prior to the 2020-21 academic year;
- Enrolled at Hampton during the spring 2021 semester;
- Determined by the Financial Aid Office to be eligible for Title IV aid; and
- Determined by the Financial Aid office to be eligible for Federal Pell Grant.

#### INSTRUCTIONS OR DIRECTIONS PROVIDED TO STUDENTS

Eligible students received emails notifying them of their eligibility and the award that they were going to receive. From the higher Education Emergency Relief Fund (HEERF II) to provide support to our students who were impacted by the COVID-19 pandemic. These students were told that their receipt of the award was based on the assumption that have incurred or will incur expenses related to the disruption of campus due to the pandemic for any component of their cost of attendance, such as tuition, food, housing, health care (including mental healthcare or child care.

### **FUNDS AWARDED**

The University received \$5,121,053 from the Department of Education pursuant to the University's Certification and Agreement for Emergency Financial Aid Grants to Students.

### **FUNDS DISTRIBUTED TO STUDENTS**

A total of \$4,905,881 in emergency grant funding through the CARES Act (student portion) was distributed to students as of March 31, 2023.

### **STUDENT ELIGIBILITY**

During our preliminary assessment of student eligibility, we determined that 3,963 met the Title IV eligibility criteria set by the Department of education, and 868 met Federal Pell Grant eligibility.

### **NUMBER OF STUDENTS RECEIVING FUNDS TO DATE**

Emergency grant funding through the CARES Act was distributed to a total of 758 students as of March 31, 2023.

### **METHODOLOGY USED TO DETERMINE GRANTS TO STUDENTS**

Hampton uses the following methodology to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a) (1) of the Cares Act:

- Must have been enrolled during the spring 21 academic semester as of March 2021
- Must have been enrolled in at least 6 credit in a degree-seeking program or in a Teacher Certification program
- Submitted FAFSA for 2020-21 aid year
- Must have made satisfactory academic progress toward the completion of degree or Teacher Certification Program.

Hampton uses the following criteria to determine student eligibility for CARES Act Emergency Financial Aid Grants:

- Determined by the Financial Aid Office to have exceptional need
- Determined by the Financial Aid Office to be enrolled as an undergraduate, graduate professional, on-line student
- Pay the outstanding balances of eligible undergraduate students who were enrolled at the end of Spring 21 semester, as determined by the Financial Aid Office.

#### INSTRUCTIONS OR DIRECTIONS PROVIDED TO STUDENTS

Eligible students received emails notifying them of their eligibility and the award that they were going to receive from the higher Education Emergency Relief Fund (HEERF III) to provide support to our students who have experienced financial hardships due to the COVID-19 pandemic. These students were told that their receipt of the award was based on the assumption that have incurred or will incur expenses related to the disruption of campus due to the pandemic for any component of their cost of attendance, such as tuition, food, housing, health care (including mental healthcare or child care).

Hampton also posted information regarding CARES Act Emergency Financial Aid Grants eligibility on the website.

As of March 31, 2023, from HERRF I, HEERF II and HERRF III, the total amount disbursed to students is \$9,170,223.
